Details of Cover

Subject to the conditions of the policy to be issued, cover shall be as set out below (one of the following):

Limited Cover:

As per London Institute Cargo Clauses (C), Cl. 254 dated 1.1.82 or their equivalent for air shipment, covering the following perils only:

Loss of or damage to the subject-matter insured reasonably attributable to fire or explosion; vessel or craft being stranded, grounded, sunk or capsized; overturning or derailment of land conveyance; collision or contact of vessel craft or conveyance with any external object other than water; discharge of cargo at port of distress. Loss of or damage to the subject-matter insured caused by General Average sacrifice; jettison.

Including theft of entire vehicle only.

"All Risks" Cover:

All Risks of physical loss and/or damage as per Institute Cargo Clauses (A)/Air. Vehicles shipped by sea in open-top/open-side/flat container are covered only as per the "Limited Cover" above. Excluding scratching, denting, bruising and claims for repainting. No claims for loss or damage to contents of vehicle but Underwriters will be liable for claims not exceeding \$250 for loss or damage to radio sets fitted to the insured vehicle. Excluding loss of cassette recorders/CD players and/or cassettes/tapes/CD's and the like. Excluding frost damage. Excluding mechanical derangement unless caused by external impact to the vehicle. If shipped on deck – excluding rust, oxidation and discoloration.

Warranted that a pre-shipment condition report is prepared by the freight forwarder.

Both Types of Cover:

No risk covered when under own power except while being driven on or off vessels and/or conveyances.

No third-party liability risk is insured.

Shipments by sea and air are covered against the risks of war and strikes, subject to the Institute War and Strikes Clauses.

Deductible: Policy will be subject to a deductible as shall be mentioned in the "Confirmation of Insurance" to be issued.

Note: Vehicles to be insured for their full actual cash value at destination. Actual cash value is defined as replacement cost less depreciation. Shipment insured for less than actual cash value will be subject to the 100% Co-Insured Clause as noted on the "Confirmation of Insurance".
